Re: Jurisdictional Input Regarding PSYPACT

Dear Committee Members:

I appreciate the solicitation to provide jurisdiction specific input in connection with the committee's review and possible action on PSYPACT model legislation.

PSYPACT was adopted by Texas during the 86th Legislature (H.B. 1501) and while the compact is still relatively young, it is showing great promise for both citizens and providers alike. With a provider ratio of 5,439 residents for every psychologist licensed in this state, Texas adopted PSYPACT as one of the many tools intended to address our mental health workforce shortage. As a result of PSYPACT, an additional 1,708 psychologists are now eligible to deliver services (i.e., telehealth or temporary in-person services) to the residents of Texas, and this number is expected to continue to grow.

Candidly, I receive numerous emails from California licensees inquiring about the delivery of telehealth services in Texas, and I am sure this line of inquiry is not a one-way street. Simply based on the volume of inquiries the Council receives, it is reasonable to think that if PSYPACT were adopted by California it would further expand the number of providers available to Texas and California residents alike.

Lastly, in an effort to preempt any concerns about the potential for public harm by out-of-state providers, I would note that my agency has not received any complaints regarding the delivery of services by out-of-state providers practicing under compact authority. Moreover, the lack of harm to the public by compact providers thus far, together with the historical data for out-of-state providers who have practiced under a temporary license in this state, lead me to believe the risk of public harm in the future will remain negligible.

Again, I would like to thank you for the opportunity to provide input about Texas' experience with PSYPACT thus far. I would be happy to speak with the committee or its members if you have any additional questions. If you wish to speak with me via the phone, I will provide my direct contact

Dear Dr. Phillips:

We understand that the California Board of Psychology is in the process of considering the adoption of PSYPACT, the interstate compact for licensed psychologists. As you deliberate, we wish to express our concern regarding this seemingly beneficial response to the increased demand for telementalhealth services and mental health services in general. In our view, while California's adoption of PSYPACT would allow for increased flexibility and access in many cases, it represents, overall, a significant blow to equitable access, not only in the State of California, but nationwide.

Our organization represents thousands of psychologists, social workers, Marriage and Family therapists and other mental health professionals, including hundreds of California practitioners, as well as over seventy organizations, non-profits and training programs, many of which are located in your state or which have a substantial membership of California psychologists. We are a voice for psychotherapy, and are dedicated to advocating for psychotherapy access, especially for those in greatest need. As that voice, we wish to alert you to the potentially stultifying effect PSYPACT stands to have upon the practice of professional psychology in general, as well as upon mental health treatment as it is practiced in your state.

As you may recognize, there has been an increasing press over the past decade to consolidate regulatory control under the banner of non-governmental professional organizations that aim to supersede regional accreditations and states' capacities to determine the contours of professional practice as tailored to local need. The so-called Model Licensing Act, put forward by the American Psychological Association, represents one such effort in its attempt to mandate that a single accrediting body, its own, determine how psychology should be taught, researched and practiced in every corner of the US. Given the growing role of telehealth in our increasingly mobile culture, the adoption of PSYPACT nation-wide would be a de facto embrace of this restrictive Act, and would represent a step towards further dissolving the protective firewall between organizations serving the professions and licensing bodies serving the public good.

At stake is the capacity of the graduates of some of this country's most innovative and progressive regionally-accredited psychology training programs to practice within the scope of

their expertise, while their peers from APA-accredited programs will be able to attain what amounts to a more flexible and desirable licensure status. This would not simply affect the wellbeing of the thousands of graduates of regionally-accredited psychology programs in California, or even that of patients who could benefit from the continuity of care afforded by telehealth if they re-locate. As you know, the graduates of these regionally-accredited programs are both more likely to stay in-state and more likely to be employed in community mental health and other settings in which disenfranchised groups are often served. They have increased exposure to the underserved in the course of their training as a result of the more community-clinic-friendly accreditation standards afforded by regional regulating bodies for internships and post-docs, and, in turn, clinics that are more financially vulnerable have relied upon these trainees to help them meet the needs of their communities, both before and after training ends.

Thanks to the protective oversight offered by the California Board of Psychology, these regionally-accredited California programs are viewed as engines of diversity within the field of academic clinical psychology, offering training that reflects a broad, humanistic – and rigorous – interpretation of the clinical *science* of psychology. In fact, the accreditation rubrics offered by the American Psychological Association have increasingly been concerning to those who have bemoaned a spreading monoculture within APA-approved programs, as expressed in the attached addendum. Rather, the culture of psychology is nurtured and enhanced by the perspectives offered by these innovative programs, which allow for the exploration of theories and methods of treatment that students in nationally-accredited programs often have less leeway to consider. We don't need to tell you that if the graduates of these programs face discrimination in their ability to practice, the programs themselves will wither. This would constitute an irreparable loss to the citizens of California and to the field of psychology as a whole.

There is no doubt that these are strange, disrupted and disrupting times. All of us have had to act quickly to meet needs we could not otherwise have foreseen as the pandemic has generated tragedy and opportunity, transformed social life and accelerated a widespread social reckoning. Above all, the past year-and-more has thrown a spotlight on a gaping psychological distress, which it is our urgent imperative to meet. Yet we cannot allow the urgency of the need and the sudden flux of our social structures to result in policies that will ultimately work against the better interests of those we serve. It is absolutely true that telehealth is here to stay, and that accommodation must be made in order to capitalize upon its promise in the best interests of our clients and our profession. But it is also true that our impulse to rise to the challenges we are facing must not be exploited in the process due to pressures that the California Board of Psychology has thus far been unique in its capacity to resist. We will continue to follow the proceedings of your committee and Board with the eager hope that California might, rather, succeed in creating a model interjurisdictional provision that can best harness the promise of our technological resources for the good of California, the nation, and the profession of psychology.

The US Department of Education periodically conducts reviews of professional accrediting associations. At the APA's 2016 review, several dozen professionals offered testimony contesting its accreditation process, asserting that it was not in compliance with DoE guidelines that mandate the teaching of a representative diversity of theories, perspectives and methodologies, since the vast majority of its approved programs are dominated, functionally exclusively, by a CBT orientation, potentially creating a monopoly. While APA was not sanctioned, they were required to defend, for the first time, their accrediting procedures.

The solicitation of comments at this point in the current review cycle on the revised document entitled "Modifications to Accreditation Processes" has aroused little attention in the APA community because it requests input into terminological and procedural minutiae while failing to provide a forum for substantive discussion of the impact of the APA's accreditation standards for educational programs and their implementation. Were the APA to have acted in good faith regarding its commitments to transparency and to its claim to represent all psychologists, particularly in light of the concerns raised at its previous hearing, such substantive discussion would have been invited during the months leading up to the APA's periodic review at the DoE. By neglecting to inform the broader community of psychologists of this review, and by failing to engage them beforehand, the APA foreclosed upon an opportunity to fulfill its ethical imperative to represent a vision of psychology education that is truly diverse.

Instead, the APA quietly reaffirmed its commitment to accreditation standards that allow for the constriction of psychology to a monoculture which increasingly appears to rest upon a singular, and to our minds, singularly impoverished, view of science and practice. While its accreditation documents acknowledge the need to respect the diversity of psychology's practitioners and clients, if not as explicitly its cultures and methods, the supremacism of "evidence-based" approaches and the requirements for teaching them leave little room, and even less good-will, let alone respect, for the developmental cultivation of a plurality of sciences and their accompanying pluralities of evidence, methods, outcomes and empiricisms.

Rather, these programs have monopolized both teaching and research in psychology departments, effectively disenfranchising the perspectives that psychology needs in order to maintain itself as a human science. In numerous ways, these continued reaffirmations of psychology as natural science, especially regarding understanding and addressing human psychological experience, reflect patterns of epistemological violence[1] which are harmful to the field as a whole, but especially to minority communities, whose continued marginalized status is further reinforced by a science based exclusively on "normative" measures,

assessments, and treatments that have often been used to their detriment[2]. While we have a century and more of evidence that therapies of depth, insight and relationship ameliorate suffering and transform lives, we have a similarly extensive accumulation of evidence to suggest that “science,” without its moral compass, its routine interrogation of reductionism and its appreciation of the complexities, ambiguities and creative possibilities of lived experience, can easily be perverted in the service of instrumentalism, economic interest and, worst of all, supremacy at all levels.

To those who claim that APA does, indeed, promote such diversity in their accreditation standards, we suggest you turn to the outcome data yielded by the implementation of these standards, which indicate, for example, that there are no advertisements for psychoanalytic or humanistic faculty positions in the APA’s flagship publication, commensurate with the number of supportive articles on those topics in that same journal. Further, a current search of advertisements for faculty position on PsychCareers, an APA search engine, demonstrates that none of the positions in APA academic institutions in the U.S. specifically seek faculty expertise in psychodynamic, psychoanalytic, or humanistic psychology (i.e., orientations that are represented by large numbers of APA members) while there are dozens of currently available “behavioral,” “cognitive-behavioral,” “cognitive,” and “evidence based” positions. Moreover, qualitative or human science approaches are nearly absent in these job calls, while academic experts in statistics are among the most commonly desired by programs supposedly dedicated to the teaching of psychology practice. We should add that the CoA’s reluctance to reveal information about how programs self-identify (as scientist-practitioner, scholar-practitioner, etc.) further impedes open and honest discussion of this situation.

We do not need to tell you that psychology’s efforts to serve the public have, for the most part, failed. Despite a century and more of supposed innovations in treatment, rates of emotional distress have not evidenced psychology’s success, as a body of knowledge or a method. We urge you to engage, as a valued aspect of preparation for all future reviews by both DoE and CHEA, in a critical re-evaluation of your teaching programs and their actual practices by soliciting the insights of those who have substantive perspectives from the margins. We look forward to the day when APA truly represents all psychology, and we stand ready to help it reach that goal.

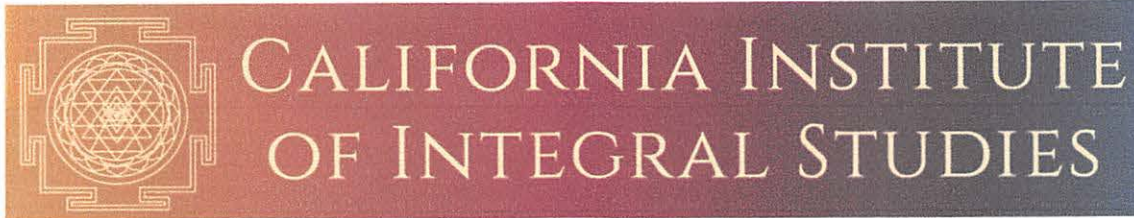

Dear Dr. Phillips and California Board of Psychology,

I am very disturbed to hear that on April 30th, 2021, the Board of Psychology is considering accepting guidelines proposed by PSYPACT, a interjurisdictional organization that has designed standards for psychologists providing telemedicine. If approved, PSYPACT restricts telemedicine psychotherapy to psychologists who attended APA-approved programs ONLY. Graduates of regionally accredited doctoral programs could become indefinitely restricted from providing telemedicine psychotherapy as a result.

It is inappropriate to assume that only APA-approved programs can adequately train psychologists to do telemedicine without any evidence to that effect. There is no evidence that currently licensed psychologists from APA-approved schools have already received training in telemedicine.

It would make more sense to rule that ALL licensed psychologists, regardless of where they went to school,

get specific training in telemedicine.

I graduated from Saybrook Graduate School in 2005, earned my license in 2006, and have been in private practice for 15 years. Under these new guidelines I would be restricted from doing telemedicine psychotherapy and my patients would not receive the care they need.

The Board is supposed to be protecting patients from harm but this change would hurt my patients who have been relying on me to provide services during a pandemic. I hope the Board votes NO and continues to focus on monitoring complaints from patients regardless of where their providers went to graduate school.

It was shocking and deeply disturbing to learn of PSYPACT's proposal to ban clinicians who have graduated from regionally accredited institutions from practicing teletherapy. I am a graduate of Pacifica Graduate Institute's clinical doctoral program, and as a licensed psychologist I serve many vulnerable populations through teletherapy. I see elderly Medicare clients, survivors of complex trauma, survivors of human trafficking, and many clients from diverse, poorer communities, all of whom would not be able to receive therapeutic support, if I was unable to provide teletherapy. It is particularly tragic that PSYPACT would propose these restrictions during a time when the world is reeling from a global pandemic, which continues to threaten the most vulnerable among us, and disproportionately, Black and Brown communities.

As healthcare providers, aren't we first called to do no harm? Shouldn't we be seeking to expand the availability of quality care to those in need, rather than cutting it by 30%, which as I understand it, would be the impact of this ban?

From another perspective, this proposal is illogical. I am of a high enough professional and academic caliber to have earned a license from the California Board of Psychology to practice psychotherapy, teletherapy, and assessment, but all of a sudden I'm not good enough to practice teletherapy, because my school was not APA accredited? Nonsense. In fact, towards the recent renewal of my license, I completed CEs about ethical, effective teletherapy practice, because I AM a responsible, mindful, clinician who strives to provide the highest level of care to my clients.

Also, if I am not mistaken, isn't PSYPACT an interstate compact that was designed to allow licensed psychologists to temporarily conduct teletherapy across state borders? What does this have to do with my local, in-state practice of teletherapy? Why are they now empowered to police in-state teletherapy practices?

Within the context of the turmoil, pain, and suffering that so many communities are enduring, I think it would be cruel and wholly unethical to adopt PSYPACT's proposal. As a licensed psychologist who worked hard, and in good faith to complete a doctoral degree that meets BOP standards, and further meet all state licensure standards to be able to provide psychological services in the state of California, I think this proposal is unfair and unethical to say the least.

I strongly oppose the PSYPACT teletherapy ban, and I urge the Board of Psychology to do the same.

Dear Dr. Phillips and California Board of Psychology Members:

I hope this message finds you well. Some colleagues sent a letter and petition, of which I signed, concerning the upcoming CA Board of Psychology meetings that will discuss the pros and cons of California becoming a PSYPACT state. In the spirit of advocating for equity and inclusion, my colleagues' letter emphasized strong opposition against the ASPPB/PSYPACT criteria that confines the acceptance of PSYPACT applications only to psychologists who have received their doctoral degrees from APA accredited institutions. Should the CA Board of Psychology decide to sign on to become a PSYPACT state, this will augment the exclusionary trend that is already occurring nationally.

While it is acknowledged that interstate telepsychological services practices may be a desirable outcome of PSYPACT, the fact that PSYPACT excludes those from non-APA accredited institutions is exceedingly unfair. In this light, it seems that reaching out to ASPPB and PSYPACT would be an important endeavor for both the CA Board of Psychology and individual psychologists to advocate for equal opportunity in interstate telepsychological practices.

As we know, California is a unique state with a great number of psychologists. It is understood that California psychologists, regardless of APA or non-APA graduate school status, may continue to offer telepsychological services within California on an intrastate basis. This is much appreciated, since many psychologists work with marginalized populations who may have difficulties with transportation and/or health issues that keep them homebound. The concern is that psychologist who value the work of telepsychology and who wish to participate in the burgeoning developments in the field such as interstate telepsychology practices not be excluded from their peers based on the university they attended.

I have attended some of the CA Board of Psychology meetings in the past and I have been impressed by the open discussions and listening that has occurred. I trust that the same passion for justice that I have observed in the past remains vibrant and that those of you on the board who will make the final call on this important consideration will continue to advocate for the many and diverse psychologists in California.

This has been quite a year for all of us! One thing that seems to have emerged is a deeper acknowledgement of the illusion of separateness and a broadening ethic of care. Thank you for taking the time to read this letter and to take these considerations into your upcoming meetings.

I am submitting this letter to you on behalf of the California Psychology Internship Council (CAPIC) Board of Directors. We would like to bring to you our concern pertaining to the upcoming California Board of Psychology Telepsychology Committee Meeting at which the agenda indicates the ASPPB will attend to discuss the PSYPACT with the Committee Members.

As you are aware, over the 30 years of CAPIC's existence, our membership has and continues to be a compilation of doctoral programs in clinical, counseling, and educational psychology, as well as predoctoral and postdoctoral psychology internships. CAPIC is recognized in the California Board of Psychology Rules and Regulations. Our 25 California doctoral psychology program members are comprised of 10 that are regionally accredited institutions, and 16 which also hold APA accreditation status.

The PSYPACT criteria as stated on their website descriptive material and eligibility criteria, excludes licensed psychologists whose doctoral degree in psychology is not from an APA accredited doctoral program. The CAPIC Board interprets the exclusionary criteria for application and subsequent inclusion in participating in the PSYPACT to be discriminatory at best. No rationale reason can be fathomed as to why the ASPPB would exclude non-APA accredited program graduated psychologists from access to provide Telepsychotherapy services through their PSYPACT.

Attached, please find the sections of the California Board of Psychology Rules and Regulations which identifies two sections of the Regulations that stipulate the inclusion of doctorate programs in psychology from a college or institution of higher education that is accredited by a regional accrediting agency recognized by the U.S. Department of Education as valid for licensure in our State (Article I, Chp. 6.6, 2914 (c) (1); and Title 16, Div 13.1, Article 2; 1386.2 (3)). The exclusionary criteria of the PSYPACT as currently written would have a direct deleterious impact and would diminish professional opportunities for a significant number of licensed California psychologists that meet State of California licensure criteria.

Of potential concern would be whether the Board of Psychology accepting and implementing the PSYPACT in our State of California be viewed as a restraint on trade on those psychologists excluded. Secondly, we anticipate significant financial damages due to those excluded based on an interference with business advantage. In addition, it is of concern that a conflict of interest may be inherent to the PSYPACT process as it may be viewed as self-serving. ASPPB and the APA may collect fees from applicants and other funding streams that would make it more profitable to promulgate an inclusion-only of APA accredited program graduate licensed psychologists.

Perhaps more importantly is what appears to be a lack of respect for the quality and range of educational opportunities which PSYPACT criteria does not seem to honor. Our State has a rich history of diversity of its residents which is reflected in both the consumers of psychological services as well as those who seek to acquire the commensurate education leading to licensure as a psychologist. It would seem counter to what our great State holds dear to entertain a program that would undermine the values related to diversity of persons and opportunities.

The California Psychology Internship Council Board respectfully requests the Telepsychology Committee consider our significant concerns for the various reasons stated above. We are requesting an opportunity to formally address our concerns with the Committee prior to the Committee taking any action. BUSINESS AND PROFESSIONAL CODE  
GENERAL PROVISIONS

ARTICLE I; Chapter 6.6 – PSYCHOLOGISTS; GENERAL PROVISIONS;

2914. Applicant's requirements Each applicant for licensure shall comply with all of the following requirements: (a) Is not subject to denial of licensure under Division 1.5 (commencing with Section 475). (b) Possess an earned doctorate degree (1) in psychology, (2) in educational psychology, or (3) in education with the field of specialization in counseling psychology or educational psychology. Except as provided in subdivision (h), this degree or training shall be obtained from an accredited university, college, or professional school. The board shall make the final determination as to whether a degree meets the requirements of this section. **(c)(1) On or after January 1, 2020, possess an earned doctorate degree in psychology, in educational psychology, or in education with the field of specialization in counseling psychology or educational psychology from a college or institution of higher education that is accredited by a regional accrediting agency recognized by the United States Department of Education.** Until January 1, 2020, the board may accept an applicant who possesses a doctorate degree in psychology, educational psychology, or in education with the field of specialization in counseling psychology or educational psychology from an institution that is not accredited by an accrediting agency recognized by the United States Department of Education but is approved to operate in this state by the Bureau for Private Postsecondary Education. (2) Paragraph (1) does not apply to any student who was enrolled in a doctoral program in psychology, educational psychology, or in education with the field of specialization in counseling psychology or educational psychology at a nationally accredited or approved institution as of December 31, 2016. **(3) No educational institution shall be denied recognition as an accredited academic institution solely because its program is not accredited by any professional organization of psychologists, and nothing in this chapter or in the administration of this chapter shall require the registration with the board by educational institutions of their departments of psychology or their doctoral programs in psychology.** (4) An applicant for licensure trained in an educational institution outside the United States or Canada shall demonstrate to the satisfaction of the board that he or she possesses a doctorate degree in psychology that is equivalent to a degree earned from a regionally accredited university in the United States or Canada. These applicants shall provide the board 109 Bus. & Prof. Code Bus. & Prof. Code BOARD OF PSYCHOLOGY with a comprehensive evaluation of the degree performed by a foreign credential evaluation service that is a member of the National Association of Credential Evaluation Services (NACES), and any other documentation the board deems necessary.

Dear Dr. Stephen Phillips,

I am writing in response to the recent announcement regarding guidelines between the BOP and PSYPACT that would effectively permit only clinicians from APA schools to conduct telehealth with patients in the state of California. This proposal is horrifying and negligent as it would impact hundreds of thousands of clinicians from non-APA schools and their patients, which, collectively, could account to a million individual lives impacted.

This proposal would impact most people, but specifically our most vulnerable, people of color, and those marginalized due to personal and/or social inflictions of suffering. My caseload alone speaks to this population. A world-wide pandemic that has ravaged our patients has left them alone, fearful to be in contact with a clinician, yet desperate for care. Telehealth has allowed me to support them to create a more psychologically sound life. These clients have expressed interest in continuing with telehealth as it has saved their lives and are grateful for the option. Hence, a licensed clinician with years of training from a non-APA school can help individuals as effectively as those from APA schools, using these online platforms.

There are those individuals who will always require telehealth such as those who are escaping intimate partner violence (IPV). Currently, telehealth has allowed me to work with a client in a potentially lethal IPV dynamic escape her living situation and file various legal suits. In conjunction with her legal team, we have been able to establish a plan and provide excellent emotional care for this individual. As this person's ex-partner put multiple trackers on this individual, it is no doubt that telehealth can be a key to supporting these kinds of cases where perpetrators could impact patients and even clinicians through tracking. To eliminate non-APA school clinicians, this will no doubt leave thousands of individuals and their children in harm's way.

I, humbly, request that the board consider the quantity and quality of people that would be impacted by this. The world has changed, and our board needs to meet the demands of our time. The argument that APA-schooled clinicians know more about telehealth or have some greater set of wisdom regarding this platform than non-APA individuals hold no merit. Furthermore, I do find it odd and highly concerning at the ethical and legal level that such issues would be happening at the doctoral level yet are not being proposed by the board of behavioral sciences (BBS). It leads many to assume a political nature to this. Such changes, as it impacts possibly millions, if we account clinicians and patients, should be done through public dialogue and not in privacy.

I thank you in advance for your work in supporting patients. I appreciate you reading. I implore your consideration in securing telehealth is made accessible to all clinicians for the benefit of all patients.

Dear Dr. Phillips and Members of the Board of Psychology,

We are writing to express our concern regarding the Board of Psychology's decision to consider participation in PSYPACT, the interstate compact for licensed psychologists. It is our understanding that the board has decided to review the proposed guidelines for telemedicine set forth in PSYPACT at its meeting on Friday 30 April. While many states have thus far approved PSYPACT's guidelines, we see this proposal as a threat to equity, for patients/consumers of psychological services, for the many psychologists educated at regionally-accredited doctoral programs, and for regionally-accredited doctoral programs themselves, many of which are located in our state.

We are especially concerned that PSYPACT's standards are inclusive of only those psychologists who graduated from APA-accredited doctoral programs. As you know, this excludes a substantial number of psychologists and doctoral students in the state of California who graduated from regionally-accredited programs. We view the APA requirement as a threat to diversity in the field of clinical psychology both regarding access to clinical services and regarding training, supervision, and clinical work, in the ways we outline below:

First, limiting consumer access to only those psychologists who graduated from APA-accredited schools has serious implications. Regionally-accredited doctoral programs are, by our estimate, responsible for the education of at least 30% of the clinical psychologists in California.. Cutting numerous fully-licensed psychologists who train and practice in this state out of the available pool of telemedicine providers will dramatically limit both the availability and the range of services, likely leaving consumers unable to access care when they need it most. Meanwhile, students who graduate from regionally-accredited programs are more likely to stay in state after graduation, and are more likely to provide counseling services directly to diverse members of our communities. For example, many of the trainees and graduates of these non-APA programs offer much-needed support to those clinics and organizations that provide the majority of clinical care to marginalized and underserved people. Disqualifying these licensed psychologists from providing telemedicine psychotherapy is a particularly serious threat to patients who are now working virtually with these providers, as well as to the many who require such help but have, as yet, been unable to access it. In short, such standards put consumers' well-being, health and safety in peril.

Second, adoption of PSYPACT's interjurisdictional proposal limits diversity in the theoretical orientations of psychologists as well as in the range of programs in which they train. Whereas APA accreditation efforts over the past decades have moved mainstream psychology toward a mono-theoretical orientation in a majority of doctoral training programs (Levy & Anderson,

2013), numerous non-APA-approved programs, many of them in California, have maintained a long-standing and vital commitment to diversity in their theoretical and clinical approaches. As you know, psychological services are most effective when multiple voices and perspectives are available to inform them, and numerous forms of research evidence demonstrate the efficacy of diverse forms of clinical care, despite the narrow standards and definitions set forth by APA's Committee on Accreditation. PSYPACT will severely restrict consumers' access to theoretically diverse practitioners, limiting them to working with clinicians from programs whose faculty are nearly exclusively cognitive behavioral and behaviorally oriented, despite the significant evidence base for humanistic, psychodynamic, family systems and other diverse approaches. This *de facto* exclusion of so many theoretical traditions shrinks diversity of thought and creates a near-monopolistic constriction of services available to consumers. Additionally, if students perceive that their degrees will not allow them to stay adaptive and flexible in a changing clinical environment, but rather will exclude them from providing tele-psychotherapy services, these schools will see their enrollments decline, putting their viability in danger. Closing these schools because of the devaluation of the degrees they grant will be a tragic blow not merely to California patients and clinicians, but to the field of psychology as a whole.

Third, adoption of PSYPACT allows an out-of-state, non-governing professional organization to regulate and control the standards of California's professional psychologists. This development has potential risks that far exceed the scope of clinical practice. Adopting PSYPACT would essentially cede regulatory power to a guild organization whose role is to protect itself and its members, rather than consumers and citizens. Instead, California's psychologists should be beholden only to its own Board of Psychology, through which we are now licensed. We view this latest effort to encroach on the BoP's regulatory authority as a continuation of previous attacks on the integrity of the California licensure process. Allowing PSYPACT to decide which psychologists can and cannot provide tele-care restricts the state's ability to adapt to the specific needs of the individuals and communities in our state.

The BoP's by-laws specifically indicate that regional accreditation is sufficient for licensure; thus, approving PSYPACT would constitute a clear violation of regulation #2914, which stipulates that educational institutions will not be denied recognition due to a lack of accreditation by a specific professional organization. California psychologists do not need regulation by an out-of-state professional organization. We are a powerful community of capable practitioners, and the regulations put forth by our state are unique to its needs. Instead, we urge the California BoP to appreciate that its strong stance will send a clear message to APA and other national organizations that supposedly represent clinical psychologists regarding their exclusionary practices, their growing monoculture, their adherence to epistemologically problematic views of "evidence," and their continued disregard of states that adhere to a vision of wider access to care and training.

We the undersigned urge the Board to resist the PSYPACT proposal. California has the largest community of psychologists in the country, representing approximately 20% of the U.S. total. The PSYPACT proposal has presented the Board with the opportunity to use its own voice for

this extensive constituency in order to ensure fairness and equity for licensees, students, and consumers of psychological services throughout the state of California. Telehealth will certainly be essential in the coming years, but the Board can do better than PSYPACT.

Senators and Representatives,

Today I am returning Enrolled Senate Bill 758 and Enrolled House Bill 4042 to you without my approval. These bills would bind Michigan to the Psychology Interjurisdictional Compact and the Nurse Licensure Compact, respectively.

The Constitution of 1963 provides that “[t]he public health and general welfare of the people of the state are hereby declared to be matters of primary public concern. The legislature shall pass suitable laws for the protection and promotion of the public health.” Art. 4, sec. 51. While I value interstate cooperation, especially around issues that are peculiarly interstate in nature, these compacts require Michigan to cede its sovereign interest in regulating health professions to an outside body.

Forfeiting our prerogative as a state to set the standard of care required of nurses and psychologists practicing in our state would violate the command of section 51 of article 4. I am therefore vetoing this bill. I look forward to continuing to work with you to expand access to quality health care for Michiganders.
