Staffing:

Liezel McCockran accepted a promotional position to Associate Governmental Program Analyst (AGPA) at the California Conservation Corp, and Julie Brown accepted a promotional position to AGPA at the Medical Board of California. Their last day at the Board of Psychology was Friday, October 9, 2015. We are currently interviewing for the two vacant Staff Services Analyst positions and should have the position filled by the end of November.

Application Processing Timeframes as of October 30, 2015:

Licensing staff continues to achieve and maintain a two week timeframe to review initial applications for psychology licensure and psychology registration, and less than one week timeframe to review initial psychological assistant applications.

BreEZe Update:

The Department of Consumer Affairs is scheduled to transition additional Boards and Bureaus to the new BreEZe online licensing and enforcement system in January 2016.

The transition to the new system will require a temporary shutdown of all licensing processes for several business days, and could result in delays in processing initial license applications, license renewals, and changes such as name changes or changes of address. This shutdown is scheduled to begin Thursday, January 14, 2016 through Monday, January 18, 2016.

- **License Renewals:** Individuals holding a professional license with December 2015 or January 2016 expiration dates who wish to renew their licenses are strongly encouraged to renew as early as possible, preferably **before the end of November 2015**.
- New Licenses: Individuals seeking a new license are strongly encouraged to apply before November 23, 2015 or after January 2016 to help avoid delays in license issuance.

Proposed Statutory Changes:

AB 705 (Eggman) Psychologists: Licensure Exemption

SUMMARY: This bill would revise and recast those provisions, and specify that those persons are not restricted or prevented from conducting activities of a psychological nature or using the official title of their position provided that they do not offer to render psychological services, as specified. This bill would instead provide that the law does not restrict the practice of psychology on the part of a person who is a salaried employee of an accredited or approved academic institution, public school, or governmental agency, and would delete the prohibition on providing direct health or mental health services. The bill would additionally require an employee of an accredited or approved academic institution, public school, or governmental agency to primarily be gaining the supervised professional experience required for licensure, as specified, in order to practice psychology without a license. The bill would exempt those persons from licensure for no more than 5 years from the date of employment or 5 years from 1/1/16 if already employed by an exempt setting.

-AB 773 (Baker) Psychology Licensing

SUMMARY: The Psychology Licensing Law establishes the Board of Psychology to license and regulate the practice of psychology. The law expires the term of a license based on the licensee's birth date. This bill would instead expire the term of a license at the end of a 2-year period from the date the license was issued.

-AB 1374 (Levine) Psychologists: Licensure: Requirements

SUMMARY: This bill would instead require the supervisor to submit verification of the experience to the board and authorize an applicant who obtains the experience in the United States or Canada to send verification directly to the board as determined by the board if the supervisor fails to submit the verification. By expanding the scope of a crime, this bill would impose a state-mandated local program.

-SB 479 (Bates), Held: Assembly Appropriations Committee

Subject Matter: Healing Arts: Applied Behavior Analysis.

Section Affected: PC 11165.1 Effective Date: Bill Withdrawn

SUMMARY: This bill would have established two new license categories and a registrant category under the Board of Psychology: Licensed Behavior Analyst, Licensed Assistant Behavior Analyst, and a Behavior Analyst Technician.

Although the Board agreed with the author's intent to regulate the discipline of Applied Behavior Analysis (ABA) under the jurisdiction of the Board, the Board had some significant concerns with the proposed language and adopted an "Oppose Unless Amended" position at its August 2015 meeting. The Board communicated its position to the author before the bill was withdrawn.

Approved Regulatory Changes:

Examinations, License Requirements and Waiver of Examination, Reconsideration of Examinations, Psychologist Fees Title 16, CCR, Sections 1388, 1388.6, 1389, 1392

The proposed regulation will change the law and ethics examination that is taken by applicants for licensure. Currently, applicants take the California Psychology Supplemental Examination (CPSE), but this has been determined to be duplicative of certain areas of knowledge on the Examination for Professional Practice in Psychology (EPPP). The proposed change will instead require applicants to take the California Psychology Law and Ethics Examination (CPLEE).

The Board is also seeking to have regulations addressing accommodations for English as Second Language (ESL) candidates. Currently, the Board has a policy, but this will place conditions in regulations.

A hearing took place at the Board meeting on August 22, 2014. The Board voted to modify the text to correct an error in the noticed language. A 15-Day Notice was issued and the Board delegated authority to the Executive Officer to adopt the language as modified when the comment period closed if no negative comments were received. The Board received no negative comments.

The Final Rulemaking File was approved and filed with the Secretary of State on June 10, 2015. The regulations became effective on July 1, 2015.

Pathway to Licensure:

Licensing staff has completed their review of all statutes and regulations affecting the pathways to licensure (i.e.: supervision requirements, psychological assistants, primary and delegated supervisor's responsibilities, out-of-state experience, etc.). Staff's suggested changes will be reviewed by the Licensing Committee at their January 11-12, 2016 meeting. After the Licensing Committee review, Staff will organize an interested parties meeting to all stakeholders to review all proposed changes. The suggested changes would then be reviewed by the Licensing Committee for final recommendation to the full Board at the August 2016 meeting.






Applications Received July 2015 - June 2016




Total of 375 Psychological Assistant Applications Received for July - September 2015
