Staffing:

On December 2, 2015, Rob Loyola transferred from the Enforcement Unit as an Enforcement Analyst to be a Licensing Analyst in the Licensing Unit, and Chris Siepert promoted from an Administrative Technician in the Administrative Unit to a Licensing Analyst in the Licensing Unit.

Application Processing Timeframes as of February 5, 2015:

Licensing staff continues to achieve and maintain a two week timeframe to review initial applications for psychology licensure, and a one week timeframe to review initial psychological assistant and registered psychologist applications.

BreEZe Update:

The Department of Consumer Affairs' transition of additional Boards and Bureaus to the BreEZe online licensing and enforcement system was completed on January 19, 2016. The transition appears to have minimal impact on our Board.

Statutory Changes Effective 1/1/16:

Sections 2909, 2909.5, & 2910 of the Business and Professions Code (BPC) - (AB-705) Exempt Settings

SUMMARY: This statute was revised to instead provide that the law does not restrict the practice of psychology on the part of a person who is a salaried employee of an accredited or approved academic institution, public school, or governmental agency, and would delete the prohibition on providing direct health or mental health services. The bill would additionally require an employee of an accredited or approved academic institution, public school, or governmental agency to primarily be gaining the supervised professional experience required for licensure, as specified, in order to practice psychology without a license. The bill would exempt those persons from licensure for no more than 5 years from the date of employment or 5 years from 1/1/16 if already employed by an exempt setting.

Section 2982 of the BPC – (AB-773) Licenses

SUMMARY: This statute was amended to expire the term of a license at the end of a 2-year period from the date the license was issued, instead of an expiration date of a license based on the licensee's birth date.

Section 2914 of the BPC - (AB 1374) Psychologists: Licensure: Requirements SUMMARY: The amendment of this section require the supervisor to submit verification of the experience to the board and authorize an applicant who obtains the experience in the United States or Canada to send verification directly to the board as determined by the board if the supervisor fails to submit the verification.

Proposed Statutory Changes:

AB 1715 (Holden): Assembly Appropriations Committee

Subject Matter: Healing Arts: Applied Behavior Analysis.

Section Affected: PC 11165.1

SUMMARY: This bill would have established two new license categories and a registrant category under the Board of Psychology: Licensed Behavior Analyst, Licensed Assistant Behavior Analyst, and a Behavior Analyst Technician.

Although the Board agreed with the author's intent to regulate the discipline of Applied Behavior Analysis (ABA) under the jurisdiction of the Board, the Board had some significant concerns with the proposed language and adopted an "Oppose Unless Amended" position at its August 2015 meeting. The Board communicated its position to the author before the bill was withdrawn.

AB 750 (Low) Business and professions: licenses

SUMMARY: Authorizes any of the boards, bureaus, commissions, or programs within the Department of Consumer Affairs to establish by regulation a system for a retired category of license for persons who are not actively engaged in the practice of their profession or vocation. Prohibits the holder of a retired license from engaging in any activity for which a license is required, unless regulation specifies the criteria for a retired licensee to practice. Requires investigations of retired or inactive licensees.

Pathway to Licensure:

The Licensing Committee is currently in the process of reviewing staff and legal counsel's recommended amendments to statutes and regulations leading to the pathways to licensure (i.e.: supervision requirements, psychological assistants, primary and delegated supervisor's responsibilities, out-of-state experience, etc.) and will present language to the Board for consideration at a future meeting.






Applications Received July 2015 - June 2016




Total of 589 Psychological Assistant Applications Received for July - December 2015
