SUBJECT	(Agenda Item #7(a)(i)(B) – AB 1074 (Maienschein) Knox-Keene Health Care Service Plan Act of 1975				

Background:

This bill would require a qualified autism service professional or a qualified autism service paraprofessional to be supervised by a qualified autism service provider for purposes of providing behavioral health treatment. This bill would also authorize a qualified autism service professional to supervise a qualified autism service paraprofessional. This bill would also specify that the behavioral health treatment may include clinical case management and case supervision.

Location: Assembly

Status: 02/16/2017 Introduced.

Action Requested:

The staff recommendation is for the Committee to watch AB 1074 (Maienschein). Staff will continue to monitor the development of the bill as stakeholders debate the merits of the bill's proposed expedited process.

SUMMARY

This bill would modify the employment requirements for the Qualified Autism Service Professional (Professional) and Qualified Autism Service Paraprofessional (Paraprofessional). Additionally, this bill would modify when a Professional can supervise a Paraprofessional. This bill would also remove the requirement for the Professional to be an approved vendor by a California Regional Center. Lastly, this bill would make additional technical clarifying changes to the law.

RECOMMENDATION

WATCH - This bill makes multiple technical clarifying changes to the law. Board of Psychology (Board) staff do not have concerns with these provisions, with the caveat that these amendments do not remove any State oversight of these providers. Board staff will continue to monitor this as the bill moves through the legislative process.

REASON FOR THE BILL

According to the author, this bill would clarify employment requirements for Professionals and Paraprofessionals, remove the requirement for providers to first be a vendor at a regional center; while maintaining the existing education and training standards for these providers, and clarify when a Professional can supervise a Paraprofessional.

The author states that changes in the bill reflect existing practices in the field and remove unnecessary barriers for providers. According to the author, making these minor changes will provide clarity for employers, health plans, and increase access to care.

Healthy Families Program and those under the Public Employees Retirement System health care benefit plan or contract.

According to the sponsor, clinical case management is currently being completed as amended and the change in statute would bring the codes up to date with current practice. The removal of the Welfare and Institutions Code reference is because the reference is incorrect and references an unrelated section. The exemptions are no longer necessary, as Healthy Families no longer exists, and PERS plans are required to provide the services under the now permanent health insurance mandate.

Board staff has no concerns regarding these technical amendments.

LEGISLATIVE HISTORY

AB 796 (Nazarian, Chapter 493, Statutes of 2016) removed the sunset provision set forth in SB 796 (Steinberg).

AB 1715 (Holden, 2016) would have required the Board of Psychology to license the practice of Behavior Analysis. This bill died in the Senate Business Professions and Economic Development Committee.

SB 1034 (Mitchell, 2016) would have made similar changes to AB 796, but was held in the Assembly Committee of Appropriations.

SB 946 (Steinberg, Chapter 650, Statutes of 2011) requires health plans and health insurance policies to cover behavioral health therapy for individuals with PDD or ASD. Additionally, it requires plans and insurers to maintain adequate networks of ASD service providers, and established an Autism Advisory Task Force in the Department of Managed Health Care.

PROGRAM BACKGROUND

The Board advances quality psychological services for Californians by ensuring ethical and legal practice and supporting the evolution of the practice. To accomplish this, the Board regulates licensed psychologists, psychological assistants, and registered psychologists.

Although the Board does not have direct involvement with QASP's, Professionals, and Paraprofessionals, the Board has advocated for enhanced oversight of these providers and for their licensure under the Board of Psychology. As no additional oversight of these providers has been instituted in the form of licensure, the Board has a vested interest in ensuring that these providers have some form of oversight to determine they are qualified to be providing services to this vulnerable population.

ASSEMBLY BILL

No. 1074

Introduced by Assembly Member Maienschein

February 16, 2017

An act to amend Section 1374.73 of the Health and Safety Code, and to amend Section 10144.51 of the Insurance Code, relating to health care coverage.

LEGISLATIVE COUNSEL'S DIGEST

AB 1074, as introduced, Maienschein. Health care coverage: pervasive developmental disorder or autism.

Existing law, the Knox-Keene Health Care Service Plan Act of 1975, provides for the licensure and regulation of health care service plans by the Department of Managed Health Care and makes a willful violation of the act a crime. Existing law also provides for the regulation of health insurers by the Department of Insurance. Existing law requires a health care service plan contract or a health insurance policy to provide coverage for behavioral health treatment for pervasive developmental disorder or autism, and defines "behavioral health treatment" to mean specified services provided by, among others, a qualified autism service professional supervised and employed by a qualified autism service provider.

This bill would revise those provisions, for purposes of health care service plans and health insurers, to require a qualified autism service professional or a qualified autism service paraprofessional to be supervised by a qualified autism service provider for purposes of providing behavioral health treatment. The bill would require a qualified autism service professional and a qualified autism service paraprofessional to be employed by a qualified autism service provider
