Please find attached the Overview of Enforcement Activity displaying complaint, investigation, and discipline statistics for the previous five fiscal years, and the current fiscal year to date.

At our February meeting, the Enforcement Program Manager (EPM) was asked why the Board saw such a large increase in complaint volume this year and last year and if there were any trends. The Board members also inquired if Medical Board ("MBC") and the Board of Behavioral Sciences ("BBS") were also experiencing an increase in complaints.

Referencing the BOP, MBC, and BBS there doesn't appear to be any consistent trend of increases in consumer complaints among all three Boards. The BOP received their highest number of complaints in FY 14/15, while MBC's highest number of complaints occurred in FY 13/14. For the BBS, the increase was during the period from May to June 2015. Neither the MBC nor BBS saw a spike in complaint intake at the same time the BOP did.

Possible factors to consider but which cannot be quantified:

- Covered California went into effect October 1, 2013, and the first open enrollment netted approximately 1.4 million new members through March 31, 2014. The program added an additional 500 thousand members through February 22, 2015 for a total of 1.9 million new enrollees who potentially could have also become consumers of mental health services.
- Social Media Outreach. In 2014 the BOP created Facebook and Twitter accounts.
- Online portal improvements allow consumers to research a provider and file a complaint online more easily.

• Effective 2013, consumers were able to file complaints online through BreEZe, facilitating submission of complaints.

In summary, there is no apparent reason or trend for the increase in complaints for FY 14/15 and 15/16, rather the increase may be an accumulation of possibilities.

To date, the Board has received 848 complaints and DOJ conviction reports. The Board has issued 27 enforcement citations and referred 33 cases to the Office of the Attorney General (OAG) for formal discipline. There are 45 active probationers and 41 in tolled status. The chart below details statistical data for the last three fiscal years. Five percent of the complaints submitted were forwarded to the OAG for formal discipline.

Board-Approved Schools Expressed in Ratio to Disciplinary Cases

Of the fifty-three (53) discipline records with school information sampled, ten (10) had gone to approved schools (19% of the discipline records).

To put into context, the Board has approved eight (8) schools. There are one hundred and forty (140) schools listed in our annual reports for graduates.

If we were to pursue this hypothesis further, the trend may show that those who go to Board approved schools were statistically *more* likely to be disciplined by the Board.
